SCORING:

Based on two rounds – 1.) Symmetry Group Comparisons in Posing Suits (60% of Score);
and 2.) Stage Walk in Shorts/Swimsuit of Choice (40%). All competitors will participate in both Rounds.

Posing Suit Scoring:

All contestants will be compared for body shape, symmetry, definition, conditioning, general fitness appearance, hair and grooming, and overall stage presence. *NOTE:* This is NOT a bodybuilding contest, so muscularity needn't be excessive to do well in the event. All competitors will be judged for their Model qualities, photogenic appeal and overall look.
